SECOND AMENDMENT TO THE RESTRICTIVE AND PROTECTIVE COVENANTS FOR VILLAS AT CROW VALLEY TO THE CITY OF DAVENPORT, IOWA

WITNESSETH:

WHEREAS, Developer caused to be recorded the Final Plat of Villas at Crow Valley to the City of Davenport, Iowa, in the Office of the Recorder of Scott County, Iowa as Document No. 31639-99 on September 10, 1999; and

WHEREAS, Developer caused to be recorded the Restrictive and Protective Covenants for Villas of Crow Valley to the City of Davenport, Iowa, in the Office of the Recorder of Scott County, Iowa, as Document No. 2000-05801 on March 3, 2000, hereinafter "the RAPC" which include scriveners errors are in the RAPC that need to be corrected; and

WHEREAS, Article IX of the RAPC allows amendments during the time in which there are two classes of membership in the Association only with the affirmative consent of all the Declarants and 75% of the then unit owners with their written acceptance; and

WHEREAS, Villas of Crow Valley Townhomes Association I by Patrick Dennis its President caused to be recorded an Amendment to Declaration of Restrictive and Protective Covenants for Villas of Crow Valley to the City of Davenport, Iowa, in the Office of the Recorder of Scott County, Iowa, as Document No. 2007-02897 on January 30, 2007, hereinafter "the Amendment", which was executed by the President and not with the affirmative consent of all the Declarants and 75% of the then unit owners with their written acceptance and this document intends to correct that deficit; and

WHEREAS, Developer caused to be recorded the Final Plat of Villas at Crow Valley 2nd Addition to the City of Davenport, Iowa, in the Office of the Recorder of Scott County, Iowa as Document No. 2006-26911 on August 24, 2006 including Lots 57 through and inclusive of Lot 64 hereinafter "2nd Addition"; and

WHEREAS, the Developer and the Unit Owners are desirous of having the 2nd Addition included in the RAPC; and

WHEREAS, at the time of this Second Amendment the signatories hereto represent that there are currently two classes of membership in the Association, the Declarant and 56 units are sold and these two classes are allowed to amend with the signatures of the Declarant and 42 of the unit owners, whose signatures are attached hereto and these two classes are desirous of amending the RAPC; and

NOW THEREFORE, the RAPC are hereby amended as follows:

1. The first sentence of Article I, Purpose and Declaration is deleted and restated:

Declarant is the owner of the following described real estate:

Lots 1-56 inclusive of the Villas at Crow Valley to the City of Davenport, Iowa;

and

Lots 57-64 inclusive of the Villas at Crow Valley 2nd Addition, to the City of Davenport, Iowa.

- 2. Any reference in the RAPC to the Villas of Crow Valley shall be amended to the Villas at Crow Valley
- 3. Document recorded as Document No. 2007-2897 as the Amendment to Declaration of Restrictive and Protective Covenants for Villas of Crow Valley to the City of Davenport, Iowa, in the Office of the Recorder of Scott County, Iowa, shall be accepted by this amendment with the exception that any reference to the Villas of Crow Valley shall be amended to the Villas at Crow Valley.
